As you know, our former Mayor Art Baldwin passed away on October 27, 2017. Art served the Village of Waite Hill for over 50 years, first on Village Council and then for 46 years as Mayor, the longest tenure in Lake County history and the longest continuous service in Ohio. Art was a strident believer in the impact the Waite Hill Foundation would have to assist its sole beneficiary – Waite Hill Village. Involved from the inception of the Waite Hill Foundation, he was ever diligent in promoting awareness and asking for financial contributions to the foundation.
